Dear Devotees,

The Board and Executive Committee of ICF and the Hindu Temple of Greater Oklahoma City want to thank you for your generous donations and continued support of the Temple. We would also like to thank the volunteers who have devoted their time and services to the Temple. Because of your support, 2010 has been a very successful year. This year we had several special celebrations, including Bramotsavam, which was well attended, and Diwali, which showcased spectacular fireworks. Several other religious festivals were added to the Temple calendar and celebrated. We plan to continue celebrating these festivals in the future. We had a record number of devotees, including children, contributing to the success of these festivities. The Balvikas class continues to expand enrollment with over 100 students currently participating.

In addition, your generous donations paid for the completion of the temple expansion which included the installation of nine new deities. Unfortunately, the Durga Mata idol sustained damage and a new idol has been acquired. As a result, the Temple will have another Pranaprathista for Durga Mataji in the summer of 2011.

With our growing community, the need for services and facilities is also increasing. The Temple recently hired a manager to run the Temple administration, coordinating activities with Priests, overlooking the maintenance of the Temple, and managing the Temple calendar.


In addition, to the regular functions of the Temple, there are additional activities including Bhajans, dance, and Balviklas classes, which are conducted in the open areas of the Main Hall. To conduct these activities without disturbing the worship area, the facility needs additional classrooms and a dining area. The ICF Board will be working with the Finance and Construction committees to look into the feasibility of these necessary projects.

The total cost of the recent construction was approximately \$1,200,000. The current balance on the loan with Iron Stone Bank is \$ 718,000 with an interest rate of 4.95% on a 5-year adjustable rate loan. The Temple board plans to pay off the loan within 5 years, funded by your generous contributions. It is only through your continued involvement and financial support that ICF and Hindu Temple can continue to serve all your religious, spiritual, and cultural needs.
